Needed an Armstrong, knowing the Armstrongs, they did not need me. Use to being in a region, to get Native American input you have to go after them to get them involved, but you never know what to expect. One has to expect ideas coming from an Armstrong which you do not share, but in this case will build to a knowledge base. Keith told me that the Eliott Clan is Scotland had to pledge loyalty to the Scott Clan, and my family to me went the way of the Armstrongs.

Clement Crosier before the family feuds with Kerr and Scott took in Hunters which were resettled from the Tyndale region of England just the other side of the border about 1540, to the region of Hunterhill, near the Rutherfords and Kerrs, and the Douglas of Cavers. The Hunter coming into Scotland as far as the Kerrs, Crosier, and Ellot at the time were concerned had a great resume.

As far as Lowell C. Armstrong, it is felt he was the first to recognize family, as cousins, plus along with Robert's Y-DNA analysis. 
# Uniformitarianism



#### So in that case need to reference myself;






Fig. 11 - Diagrammatic cross section across the Illinois Basin showing the stratigraphic relationship between the Salem and St. Louis Limestones.

Mathematical models are used not only in the natural sciences (such as physics, biology, earth science, meteorology) and engineering disciplines (e.g. computer science, artificial intelligence), but also in the social sciences (such as economics, psychology, sociology and political science); physicists, engineers, statisticians, operations research analysts and economists use mathematical models most extensively. A model may help to explain a system and to study the effects of different components, and to make predictions about behaviour.

Mathematical models can take many forms, including but not limited to dynamical systems, statistical models, differential equations, or game theoretic models. These and other types of models can overlap, with a given model involving a variety of abstract structures. In general, mathematical models may include logical models, as far as logic is taken as a part of mathematics. In many cases, the quality of a scientific field depends on how well the mathematical models developed on the theoretical side agree with results of repeatable experiments. Lack of agreement between theoretical mathematical models and experimental measurements often leads to important advances as better theories are developed.

One of the models which people likely will not understand, that in today's mathematics, people of not so high of mathematical intellect will utilize formulas, which even I can somewhat begin to understand, and in given time but do not like to apply myself in such manner can.

An example of this is when I went to court up against what a friend called an infallible photo radar, the prosecutor for The State of Arizona when asked said his undergraduate was in English literature, presented complex math which would confuse the average defender, but studying the frequently asked question, and the principal of accuracy and not able to get a defense lawyer interested in my case, felt that the prosecuting lawyer would do find, and I did not have to pay him.

So he put forth many numbers, and concluded I was going 11 mph or more over the speed limit the speed need for photo radar, and I used his numbers 56 speed -1 accuracy - 45 posted = 10 and was not greater than 11. Many a false ticket has been mailed. Using uniformity, many a witch in Salem have been falsely accused by educated idealism.

Those who worked as mathematicians, engineers, accountants, and scientists in the applied sense are less likely as compared to those as in other fields such as English literature are less likely to bias the numbers, and will utilized numerical analysis to problem solve.

It has been found that a lot of people which do not have the numerical background may plug in numbers but bias there output, where it is felt the persecutor for the State of Arizona in the above example. Of course with the concept that there are Salem Witches and that Photo Radar is Infallible, and the Galileo after doing his calculation is incorrect and the authority The Church of Rome that the Earth is the Center of the Solar system, my numerical way **has to be incorrect** to the historians, religious leaders and everyone else, but since I am searching for self it is important that I get is right for myself. One thing which it is felt to be correct if I error, family will error in the same direction therefore in that manner family can be recognized.

It is difficult to challenge the numbers of someone who has a large experience of numerical usage. Robert should note it took me years to begin to come to some conclusions. One thing I have problems to deal with is "dotting the i", and other people have been a great help in that area.

Basically before The Union of the Crowns. There was a self govern nation of border reiver between Scotland and England, and this Nation of Borders, is what made the border. A policy of moving or being exterminated was placed on those of the border. This effected border clans as the Ellot, Armstrong, and Graham. The Scott Clan the largest land holder in Scotland, did not have to go, nor did the Ellot which gave loyalty to the Scott Clan which gave loyalty to the king, did not have to go also.

The denial can be seen in the symbolization of Braidley being place on the, map drawn by J.A. Young, of the **Borders Regional Council**, of placing the home of the so called by the Scott Clan the notorious border reiver Martin Ellot/Elwood as being of Braidley being near the Scott estate of Branxholm, instead of just east of the Hermitage Castle between Goranberry and the Hermitage, where archeological evidence, and a series of maps shows it to be.

Let the misplacement of Braidley on map, drawn by J.A. Young, of **Borders Regional Council**, stay where it is misplaced being symbolic in its misplacement shows the denial of the holocaust bestowed on the self governing Border Nation which was once during a period between 1320-1605, between England and Scotland, and let the **Elliot Clan Society** keep this map on its sight to symbolize denial of this holocaust also.
