## Robert Elwald of Remyngton 1304

CHARTER BY ARCHIBALD, EARL OF ANGUS, IN FAVOUR OF ROBERT ELWALD OF THE REDHEUCH, OF CERTAIN LANDS IN LIDDISDALE, DATED JUNE 25, 1476.

Be it kend to all men Be thir present letteres us Archibald Erill of Anguss Lord douglas and of the lordschep of ye regalite of ledalisdall ffor till haf gyfing grantit and assignit and be yis our letteres gyffs grantts and assignis onto our velbelufyt fameliar squiar Robert elwald of ye Redheuch for his gud and faithfull servis to us don and for to be don all and haill ye lands of dalman bluntwod and ye crouke lyand with-

## Robert Elwald of Redheuch 1476

\* Robert Elwald, merchant, son of John Elwald, alderman of York, was free in 1506, chamberlain in 1530, and sheriff in 1532-3. In August, 1533, he was elected an alderman *vice* Ralph Pulleyn discharged, and "secluded" on 6th June, *seq.* He was re-elected an alderman January 10th, 1534-5, and occupied the civic chair in 1539. On 28th October, 1549, he resigned his gown, and the Council granted him a pension of £4 per annum. Mr. Robert Elwald, who was living in 1556, and Ellen his wife, appear to have been buried in the church of St. Michael-le-Belfrey.
